"JACK DANIEL'S NOW OR NEVER" PROMOTION

TERMS AND CONDITIONS

- 1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
- 2. Entry is only open to Australian residents aged 18 years or over. Employees (and their immediate families) of the Promoter, participating stores and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.

- 4. A participating store is any off-premise store nationally that stocks Jack Daniel's products and displays material relating to the promotion during the Promotional Period as well as their official online stores (each a "Participating Store").
- 5. To be eligible to enter, individuals must spend \$20 or more in a single transaction on any Jack Daniel's product/s from a Participating Store during the Promotional Period ("Qualifying Transaction"). In the event a receipt is not automatically provided, it is the individual's responsibility to request one.
- 6. To enter, upon completing a Qualifying Transaction, entrants must then visit https://nowornever.jackdaniels.com, follow the prompts to the promotion entry page, input the requested details including full name, email, mobile phone number, residential street address, date of birth and upload a copy of the purchase receipt. Individuals will then need to select one (1) of the Participating Retailers in which they made their Qualifying Transaction (from the list provided) and then submit the fully completed online entry form during the Promotional Period.

Once the completed online entry form has been submitted, entrants will receive an online message acknowledging their entry and informing them that (a) they have been awarded one (1) entry into the Major Draw (defined below); and (b) if they have won an Instant Prize (as defined below) and if so, details on how to verify their entry and claim their Instant Prize. Major Draw

- 19. Entries will be divided into one (1) of five (5) groups according to the Participating Store in which the entrant's Qualifying Transaction was made, as follows: Endeavour Group (BWS, Dan Murphy's & Jimmy Brings), Coles Liquor Group (Liquorland, Vintage Cellars & First Choice Liquor Market), Independent Brands Australia (Cellarbrations, The Bottle-O, IGA Liquor, Porters Liquor & Thirsty Camel (WA), LMG (Bottlemart, SipnSave & Thirsty Camel) or Other Independent stores (each a "Group").
